Withdrawals & Refunds

WITHDRAWALS (ALL COMPETITIONS & CHAMPIONSHIPS)

If a Branch or Centre withdraws a team or individual prior to the closing date for a competition, a full refund of entry and stabling fees will be made, less an administration charge of $\pounds 10$ per rider.

Withdrawals after the closing date for a competition will not be refunded.

ABANDONMENT (ALL COMPETITIONS & CHAMPIONSHIPS)

In the event of a competition being abandoned, for whatever reason, a refund of 50% of the entry fee will be given. In such an instance the refund process will be communicated and must be followed.

- Queries may only be raised via the Secretary by the DC or their appointee. Protests / objections will be managed as per Rule 9.
